Hence, the composition of Independent Directors in the Board is less than half of the Board as only two (2) out of six (6) Directors are independent.
	:	Even though the Board composition comprises less than half Independent Directors, the Company's Independent Directors are able to carry out their roles with their diverse perspective. Yeong Siew Lee is a member of Malaysian Institute of Accountants and has two (2) decades of finance and accounts experience. Meanwhile, Masleena binti Zaid is currently the Managing Partner of Messrs Masleena, Yee & Partners and have served as the Head of Section at the Companies Commission of Malaysia and was a Prosecuting Officer at Securities Commission Malaysia. Although Datuk Ng Peng Hong @ Ng Peng Hay is the Non-Independent Non-Executive Director of the Company, he is not the employee nor shareholder of the Company and has no relationships or circumstances which is likely to affect, or could appear to affect, his judgment as a Non-Executive Director.

The recommendation by the Board for retaining such Independent Directors would be based on their independence, incumbent knowledge and contributions to the strategic objectives and stewardship of the Company.</p>

In this regard, the Nomination Committee is charged with the responsibility of identifying, selecting and recommending to the Board suitable candidates, taking into account factors such as personal attributes, skills, experience, competence, capability, time and commitment to effectively discharge the fiduciary duties and functions with due consideration of diversity required of Directors.</p> <p>As there is no “one size fits all” and taking into account the business environment that the Company operates in, the Board authorises the Nomination Committee the option of using external independent sources, if required, in the recruitment of candidates for directorship above and beyond referrals from shareholders, Directors and Senior Management. Evaluation of candidates include the review of resumes, reference checks and interviews based on criteria established in Paragraph 2.20A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. Despite not making visible all questions posed by shareholders, the Company had undertaken to answer all the questions submitted by shareholders.  The Company had engaged Boardroom Share Registrars Sdn. Bhd. (“Boardroom”) as the poll administrators to provide the required infrastructure and tools to support among others, a smooth broadcast of the general meeting and interactive participation by shareholders.  Boardroom had verified the eligibility of shareholders/corporate representatives/proxies to attend the AGM based on the General Meeting Record of Depositors and upon the cut-off date and time for proxy form submission. The online platform provided was secured exclusively for the members with approved registration for the Remote Participation and Voting (“RPV”) at the AGM. The online platform has a moderator function to assist the Company in tracking the questions posed by the shareholders during AGM.  Questions submitted by shareholders prior to the commencement of the AGM and during the AGM via the online platform had been captured and responded to by the Chairman during the AGM.  A question and answer session has been dedicated by the Company during the AGM to allow interaction between the Directors and the shareholders. Whilst the members were in attendance in the

	<p>proceedings of the AGM, they would be able to cast their votes and submit any questions which they wish to raise.</p> <p>Although the voting session had commenced from commencement of the AGM, the Chairman had allowed additional five (5) minutes for members to cast their votes after the conclusion of the question and answer session.
